




What is the Need?

Do you have space in your home but not getting calls for placement? Does your acceptance criteria match the need for actual children in care?

Did you know that 46% of the children in care are between the ages of 12 & 21 BUT only 32% of foster parents are open to children in that age range?

School aged youth and teens are among the hardest to find placement for. Children are sleeping in offices because there are no families willing to accept them into their homes. The placement crisis is real and we need families who are able and willing to care for older children.

Do you know someone who works well with teens? Refer a family who becomes approved and you get PAID! Ask your worker how.





National Reunification Month

One Kentucky familiy was highlighted for their partnership efforts with birth families and the important role they play in reunification. Josh and Melissa Howell believe that all children should be with their birth families if at all possible. They provide a support system to families even after reunification.

Policy Update

SOP 4.28 Meeting Educational Needs has been updated and is now live with updated information about ESSA.

4.28 Meeting Educational Needs - Standards of Practice Manual (ky.gov)

The Department for Community Based Services (DCBS) will make every effort to ensure a child's educational stability and will document those efforts. Federal law requires that those efforts include:

- Agency attempts to ensure the child can remain in the same school that they attended prior to removal;
- Documentation around educational assessments and services to support the child's educational needs; and
- The appropriate transfer of school records when a change in schools is necessary.
- Prior to any school change, a 'best interest determination meeting' shall be held. A best interest meeting may be initiated by either the local school district or the SSW.
